Genworth Life Insurance Company has been selected as the new provider of voluntary group long term care (LTC) insurance for The Claremont Colleges effective January 1, 2013. Eligible participants include all actively-at-work, full-time faculty and staff ages 18 and over, who are U.S. residents working regularly at least 20 hours per week. Eligible spouses/qualified domestic partners, adult children, siblings, parents, parents-in-law, grandparents and grandparents-in-law are also eligible to apply.

During this special enrollment period, eligible employees will receive a one-time guaranteed acceptance opportunity to enroll (through age 69). Additionally, eligible spouses/domestic partners will have a one-time opportunity to enroll with simplified underwriting (through age 65).

The special enrollment period for LTC is October 22, 2012 through December 7, 2012, and during this time you can get rate quotes, product information, and can even enroll online. (Please note that the Genworth special enrollment period is limited to LTC benefits and no other benefit offered by The Claremont Colleges).
