Candidates considering any Executive Board position must attend at least three Senate related events for the current academic year they are enrolled in, or currently serve on the Senate as an Executive Board member or a student senator. If the prospective candidate does not meet either requirement, they must obtain two (2) signatures from Senate Executive Board members and five (5) signatures from CGU students to confirm their candidacy to run for office.

1. This form is to collect signatures required for board candidate nominations.
2. Candidates must obtain two (2) signatures from current members of the Senate Executive Board and five (5) signatures from current CGU students in good standing.
3. Signatures can only be obtained from current CGU students eligible to vote in Senate elections.
